EXECUTIVE SUMMARY

Hebron Fire Protection District responded to eight calls yesterday, including a vehicle fire on Petersburg Road at 1753 hours and an inside natural gas leak on Fister Place Boulevard at 1827 hours, along with multiple medical emergencies including chest pain and unconscious person incidents in Erlanger. Today's shift has sixteen personnel on duty, with Officer Matt Schneider leading Station 41, Officer William Bruns at Station 42, and Officer Michael Hoppius at Station 43. Current weather conditions show overcast skies with temperatures at seventy degrees and southwest winds at thirteen miles per hour. There are no scheduled events for today.
